- **Accounts:** The September accounts to be forwarded to DB Action SS

- **BCP Council:** Planning application 8/19/1589 74, Hurn Way, RA have sent a letter of objection, but the developer has resubmitted further changes to the application to BCP, Councillor Margaret Phipps will speak at the planning committee meeting on behalf of the local residents. The Tree and Landscape officer has rejected the developers latest proposals regarding the existing trees and proposed landscaping on site, report dated 02-10-2020.
